Benefits Assistant:

- Processes retirement packages
- Processes lump sum payments of leave and comp time for separated employees
 - Lump sum questions and documents should be emailed to sm.ap.benefits.ls@usda.gov
- Receives, reviews, and processes FEHB/FEGLI/TSP changes/enrollment forms
- Answers employee questions regarding FEHB/FEGLI/TSP enrollments/changes
- Processes range of personnel actions (SF-52s)

Benefits Specialist:

- Counsels employees about their retirement entitlements
- Works with employees on deposits and redeposits for military/Peace Corps/non-deduction service
- Provides support & information on FEHB/FEGLI issues relating to eligibility, opportunities to enroll/change coverage
- Interprets regulations & provides information on TSP
- Counsels family members and/or designated beneficiaries of deceased employees in any of the above benefits
- Determines the impact of non-pay status on benefit entitlements and provides appropriate notification to employees
- Manages correction of errors
